8. Board Issues

A. Flexible Instructional Days Application Approval Request

The Board granted permission for the Administration to make application to PDE for the Flexible Instructional Day Program beginning with the 2023-24 school term for a period of three years to allow for instructional day requirements when schools must be closed due to hazardous and/or emergency conditions.

B. School Psychology Intern
